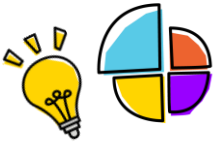

Introduction of the “Child Safeguarding School “ Award Programme

As a Child-Related Worker, have you ever thought about...?

How close are we to child maltreatment cases?

- Have you ever encountered suspected child abuse cases in your daily work and felt lost about how to handle them?
- Have you ever felt uncertain about what are the (in)appropriate behaviours when caring for or disciplining students?

The number of Newly Registered Child Protection Cases with the Social Welfare Department in 2023 has increased alarmingly, in which around 35% of the perpetrators came into contact with the victim in child-related organisations or other settings, highlighting the need for stronger institutional safety nets and public awareness.

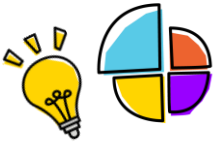
What are our responsibilities?

- As one of the most trusted adults in the lives of children, could you hear their cries for help?
- Can the School be the channel for help when children face domestic violence?
- Do parents fully understand their Duty of Care towards their children?
- Aside from community expectations, what are the legal responsibilities of child protection imposed on professionals, including teachers and social workers?

What positive transformations can the "Child Safeguarding School" Award Programme inspire?

Last year, nearly 50 early childhood education institutions joined the Child Safeguarding School Award Programme, engaging in over 150 training sessions and consultancy services. These efforts deepened the understanding of the "Child Safeguarding" concept and policies, delivering notable results:

- 100% of management found consultancy services relevant, with templates meeting kindergarten daily needs.
- 100% of staff reported heightened awareness and understanding of Child Safeguarding and child-related local regulations.
- 98% of staff better grasped their Child Safeguarding roles.
- 97% of staff endorsed implementing the “Child Safeguarding Policy” at their institutions.
- 96% of parents gained clearer insight into child abuse definitions and types post-training.
- 98% of parents understood teachers’ mandatory reporting duties after training.
- 98% of parents recognised the value of the “Child Safeguarding Policy” and their own roles in “Child Safeguarding.”

Objective

Plan International Hong Kong (Plan Hong Kong) is committed to promoting child safeguarding and supporting child-related organisations at large to set up their own Child Safeguarding Policy to prevent child maltreatment from arising in the organisation. The launch of the "Child Safeguarding School" Award Programme is a strategic initiative by PlanHK to equip kindergartens with the necessary resources and support to implement the CSP.

By participating in this programme, the institution will:

1. **Strengthen the organisational Child Safeguarding Culture** by establishing a clear set of standards and operations in its governance and activities thereby creating a safe environment for children; simultaneously nurture children's self-protection and expression via interdisciplinary educational activities;
2. **Enhance the understanding of Child Safeguarding among child-related practitioners.** This ensures that staff members are cognisant of their responsibilities and exhibit appropriate behaviors when engaging with children, thus protecting the institution's reputation.
3. **Engage in public advocacy and raise public awareness of the significance of Child Safeguarding** through parent education and stakeholder communication.
4. **Awarded as " Child Safeguarding Achievers"** and showcase your outstanding achievements and best practices via Commendation Ceremonies, Exhibitions, and media outreach to foster the culture of Child Safeguarding in Hong Kong.

Target Group

Registered kindergartens, nurseries, and child care centres in Hong Kong.

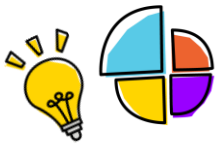
Programme Timeline

Background

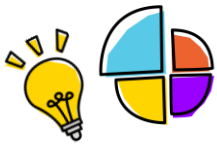

The “Child Safeguarding” Movement in Hong Kong

Since 2018, Plan Hong Kong has been committed to promoting Child Safeguarding locally and supporting child-related organisations at large with resources to set up their own “Child Safeguarding Policy” to prevent child maltreatment from arising. In 2020, we developed a localised "Child Safeguarding Policy" framework based on extensive literature reviews and research surveys, consisting of 4 dimensions and 20 standards for local educational institutions.

With support from the Wu Jieh Yee Charitable Foundation (2022-2023), we created a series of free resources to promote Child Safeguarding, including the "Kindergarten Child Safeguarding Practice Manual", an online self-learning platform, as well as teaching materials and home activity books for parents and kindergarten students. We also conducted free workshops for teachers, parents, and students to enhance their understanding of Child Safeguarding related issues, encouraging institutions to implement the CSP.

On the verge of the execution of the Mandatory Reporting of Child Abuse Bill, we recognise the pressing need in the industry for institutionalising the CSP. With the further support of the Wu Jieh Yee Charitable Foundation, we have launched the "Child Safeguarding School" Award Programme in the early childhood education sector. Plan Hong Kong will provide free consultancy services and resources for capacity building to the pre-schools, assisting them with the implementation of the CSP and evaluation of its effectiveness. An Advisory Committee and Advisors Group for Special Topics will oversee the program and assess the "Child Safeguarding Schools" with awards.

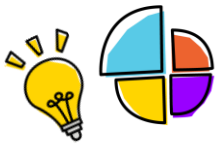

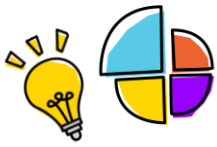


Educational Resources

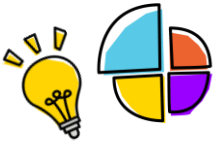
