2. Participating institutions are required to sign the "Child Safeguarding Charter" online. Please refer to Appendix 1 for more details.

However, the service schedule for supporting the "Child Safeguarding Mover" and the "Child Safeguarding Achiever" may vary slightly. Certain services, such as children's workshops and parent workshops, will be given priority to participants from the "Child Safeguarding Achiever", and the remaining slots will be allocated to participants from the "Child Safeguarding Mover".
